TRANSPORT AND PARTICIPATE SAFELY!

- Keep materials in original containers & do not combine
- Tighten caps and lids
- Pack in sturdy, upright boxes – do not bag items
- Drive directly to the event & leave items in your trunk
- Never smoke while handling hazardous materials
- Do not get out of your vehicle at the event
- Additional Instructions:

THESE ITEMS MAY NOT BE APPROPRIATE FOR HHW EVENTS:

Put in regular trash:

- Alkaline batteries (e.g. AA, AAA, 9V)
- Empty aerosol cans
- Empty or hardened paint cans (unused latex paint can be recycled into new paint)
- Smoke detectors & carbon monoxide detectors
