
Types of Participants

- Businesses or organizations in the waste reduction, sustainability, or restaurant services space with a vision to leverage these skills to enhance their value proposition and expand their impact

Benefits of Participating

This program will equip participants with skills, knowledge, and tools to effectively deliver technical assistance in implementing wasted food reduction strategies across the EPA Wasted Food Scale. The pilot will consist of a virtual training phase, which will run from mid-January through March 2025, and will cover the following:

- Conducting onsite food waste assessments to identify opportunities to reduce wasted food
- Empowering employees through education and training
- Conducting cost analyses for starting or expanding diversion programs
- Connecting with organics haulers and processors
- Sharing successes and promote best practices to reduce wasted food



Starting in April, select participants of the virtual training phase will be eligible for advanced on-site training. Over the following year, participants will put their new skills into practice by providing wasted food diversion assistance to restaurants in their own community alongside one of CET's expert waste reduction consultants.

Importance of Wasted Food Solutions

According to the U.S. Department of Agriculture, **30-40% of the food produced in America goes to waste.** This inefficiency comes at a tremendous cost—financially, environmentally, and socially.

By diverting surplus food from landfills and redirecting it to those in need, we can **strengthen food security in our communities and alleviate hunger**. Additionally, food waste in landfills generates methane, a potent greenhouse gas that contributes to climate change. Reducing organic waste **protects our environment** by preventing harmful greenhouse gas emissions, **preserving natural resources** used to produce food, and reducing reliance on landfills.

By identifying ways to prevent, recover, and divert surplus edible food, businesses can reduce disposal costs, optimize their operations, and improve their bottom line. It's an opportunity to enhance efficiency while making a positive impact on the community.
